CHAIRWOMAN DEELEY: I call this meeting of the Return Board to order to commence the Canvas and Computation for the Primary and Special Election of Tuesday, May 18, 2021.

First if there is anyone who has requests or concerns in regard to the Primary and Special Election of Tuesday, May 18, 2021 or would like to put anything else on the record in regard to the Primary and Special Election, please step forward.

MR. GARELLA: Good morning, Commissioners. My name is Rich Garella. I'm a resident of Philadelphia and a member of Protect Our Vote Philly. I just wanted to point out that once again, the opening of the hoppers from the ExpressVote XL machines and the commingling of the ballots, which has been ordered as a requirement by the Secretary of State in order to protect ballot secrecy, is not being done in a timely manner as far as we can tell.

The ballot hoppers should be opened before the canvassing computation begins, so you should really delay the canvass, we believe, until that process is finished.

Also, the ballots need to be commingled, in other words shuffled, in the presence of Board members, and it's not clear that that's happening.

I know that in some cases, it's not possible for the public to tell whether these procedures are happening correctly. I think the ideal situation is only that the public is able to see and confirm that all procedures that are designed to protect their voting rights are done correctly. Thank you.

CHAIRWOMAN DEELEY: Thank you. Anyone else for comment?

MS. McCATHY: Hello. My name is Muriel McCarthy. I live in Philadelphia and I'm an observer for the Green Party. I would just observe that the duplication of the ballots is going very well, but you need to do one more thing to meet the Election Code, and that's to put the word "duplicate" or D-U-P on the duplicated ballot.

In June and in November, we did not duplicate ballots according to the Election Code. We pointed out to you different ways, as you know. So I'm very pleased to see that you are serializing these ballots, but they also need that one extra step to meet the Election Code, and that's to put the letters D-U-P or "duplicate" on the duplicated ballot. Thank you.

CHAIRWOMAN DEELEY: We will now swear in the staff. Will the Board of Elections' Staff please rise and raise your right hand.
